JOINT REQUEST FOR APPROVAL OF SETTLEMENT AGREEMENT

Clark County School District (“CCSD”) and Moapa Valley TV Maintenance District (“MVTVMMD”), pursuant to Section 73.3525 of the Commission’s Rules¹ and the Commission’s Public Notice released October 17, 2006,² respectfully request approval of the oral settlement agreement and engineering solution described herein.

In Auction No. 85, CCSD filed an application for a digital companion channel on Channel 27 for television translator station K23CJ, Glendale, NV (File No. BSFDTT-20060630CQO), and MVTVMMD filed an application for a digital companion channel on Channel


26 for TV translator station K64CQ, Overton, etc., NV (File No. BSFDTT-20060630CAL) (collectively, the "Applications"). The Applications are mutually exclusive.³

CCSD and MVTVMMD have determined that they can resolve their mutual exclusivity through an engineering solution. Accordingly, pursuant to an oral agreement, CCSD and MVTVMMD have agreed to amend the Applications to specify the technical parameters set forth in Exhibits 1 and 2, respectively.


In support of this request, CCSD and MVTVMMD are also submitting, as Exhibits 3 and 4 respectively, the declarations required by Section 73.3525 of the Commission's Rules.⁴

Accordingly, the parties request that the Commission (1) approve this Joint Request, and (2) accept the technical amendments to the Applications that are being filed concurrently herewith. Approval of this Joint Request will serve the public interest by expediting new digital services to the public.




